Robie Creek Volunteer Fire Department:

During our fire scare we have been discussing how to help our fire department. They did an awesome job including checking the area for 5 days after the fire and department operate with volunteers and charge very little for our annual payment. SO we have a fireman's hat in the club house for donations to give the fire department at their open house at the park on Sept 11.

Reminders:

- If you do not live on the mountain you should sign in at the club house.
- Dogs are not allowed in the club house.
- Absolutely No Smoking or Vaping allowed on trails.
- Smoking or Vaping in designated areas only. Cigarettes need to be **out** when butts are disposed.

The smoking reminders are due to finding half cigarettes on needles and on steps within the campgrounds. After our fire this year it is vital that all cigarettes are disposed of correctly.
