Board and Member Attendance – Ron, Cherie, Alan and Jim present – Brent via internet. Ken present.

Acceptance of Meeting Minutes - MSA

Financial Report and Acceptance – Cherie per Donna's report. Discussed providing P&L statements form January until final budget is approved based on the proposed draft budget. Adjustment could be made to the P&L if necessary. Also discussed having the master plan include costs that may be incurred before the budget is approved by the membership (allows large projects begin before final budget approval).
